## Public Hearing – Zoning Ordinance Proposed Changes

October 1, 2025

**Call to Order:** Chairperson Mallon called the meeting to order at 4:30pm and the Pledge of Allegiance was said.

#### **Public Comment:**

Marcinak voiced concern over blight, noise, and shipping containers. As of now, when the police come out to Lake Mary for a noise complaint, they cannot issue a ticket because our township does not have a noise ordinance in place. He explained there are four-wheelers being ran day and night on both sides of Lake Mary. He stated "Shipping containers do not belong on residential lots." We were provided with an article from the Iron County Reporter titled "Why we fight Blight." Marcinak also read a letter written by Mike Webb who was not able to attend the meeting. The concerns in this letter are similar with adding trailers being parked on RR lots at Lake Mary all summer long, invading peace. We were provided with a photo of trailers lined up on a lake lot.

Gerou voiced concern over trailers being parked during every season/holiday at his neighbors. Disturbing his peace with loud music, ORVs/ATvs, and fireworks in July which he found debris of on his roof. Gerou expressed concerns with how long a trailer can sit on a property without being moved and if there is any fee that the home owners have to pay for having a trailer parked all year long. He provided us with the fees and locations of surrounding sites that are under 5 miles from Lake Mary and suggested the township have a fee for parked trailers.

Chairperson Vice Chairperson Franz explained the cycle of our current ordinance changes. Stating that every 5 years we are required to review our Master Plan, with our ordinances, while taking requests for changes and that we will be discussing our options during our Master Plan review.

C. Franz made a motion to adjourn at 5:15pm with support from P. Mallon.

Stu will work with board to create RV/trailer permit.

Planning commission will look into short term rental property guidelines/ordinances when addressing housing for Master Plan review.

#### New business:

We reviewed the survey. Motion made by P. Mallon to have the survey go live online, with support from A.Kinsey. Call to vote: all ayes, no nays. Our goal is to get as many responses as we can with a deadline of November 1<sup>st</sup>. Post cards with a QR code will be sent out ASAP.

After reviewing results from the survey, we will discuss what projects align with our township residents and visitors wants/needs. We will use this information to determine what projects take priority
